
#### A shared tool

## The analysis of the risks and the management of the prevention




The objective that proposes is of the individualization of the data of risk, the recording and the elaboration of the data and the planning of the prevention to make easy to reach the elimination of the working risks.

# To contribute to the objectives of Kyoto




Through the control of all the environmental parameters of what it enters and it produces in the firm, to facilitate the adoption of trials, of technologies and of clean products in degree not to damage the environment.

# The method of the analysis of the risks




To effect a correct analysis of the working risks, with the purpose to eliminate them, it is necessary to examine every installation, every local of the site, every phase of job that develops, every machinery that is used.

#### **Control's lists**




For the survey of the data of risk you can be used some lists of control that follow the formulation of the questions of the cards. In such way the recording of the data is simpler and besides is possible to involve, for the verifications, the appointees in the single departments. It is certain that the verification of the risks asks for the necessary technical competence and the knowledge of the activities of the technologies and of the methods.

## The driven compilation




The compilation is totally driven. For every aspect there are options to choose. If the survey has been effected on paper, the transcript of the data is very simple.

#### The data of the firm




To the card of the firm, that the administrative data contain, they make reference all the files of analysis, of registry of the workers, of verification and measure, of sanitary management, of verification and control of the environmental parameters.

#### The data of the site




From the administrative card of the site, it is possible to get the elaboration of all the data that allow the verification of the safety and the health of the workers and the environmental quality of the trials and the materials.

# In the place of job it begins the real analysis of the risks




For local a confined place is intended in which the environmental risks can spread, or an area open with a specific function. The risks examined in the place (what correct can be intervening on the structure of the place or on his inside logistics) they are those related to the emergency, to the inside circulation, to the storage, to the quality of the structure, to the illumination, to the climate, to the electric plant.

# The risks for the safety and the health provoked by the place of job




The risks of the place can influence besides the conditions of health and safety of the single phases of workmanship that develop (as to the scarce ventilation or the tall temperature or too much low). The risks are appraised in relationship to the actions that end for eliminating them.

### The prevention sets fire




Every place has a card of prevention you set fire, in which the formation of the workers, the load of fire and the classification of the risk of fire it is certified.

### The procedures of control and prevention




Every business unity (the places, the workmanships, the machineries) they can activate procedures and plannings of verification, control, intervention that concern the safety, the quality, the prevention sets fire, the emergency, the food hygiene, the sanitary management, the Iso certification.

## The phase of workmanship




How Phase of workmanship is intended that segment of the flow of job that has characteristics of homogeneous risk.

# The organization of the job




The carrying out of the job involves more normally the share offices, among which is divided and organized the activity. The analysis of the organization of the job is fundamental, in how much it allows us to otherwise organize the conditions of risk and to reduce her. The office is analyzed in the concrete operational formality.

## The chemical agents




If activity uses some dangerous materials, these can be recorded, with their characteristics of risk and can be begun to analyze the chemical risk which the workers are exposed

### The risks of the working activity




In the phase of workmanship the risks are considered more directly provoked by the formalities of carrying out of the job and by the materials that are used: I risk chemical, physical effort, noise, radiations, biological risk, terminal video

# The safety cards of the chemical agents




All the chemical agents and their components have to be recorded with the indication of their characteristics of risk and their TLV. In such way during the analysis of the risks it is possible in every phase of workmanship and on every machinery to notice the existence of chemical risk.

#### The classification of the chemical risk




The chemical agents are classified in base to their characteristics of risk. It is easily so possible to individualize where a chemical agent is used with dangerous characteristics and to replace it.

#### The machineries




All the tools are analyzed used for the carrying out of the job: machineries, fittings, equipments in the concrete state in which they operate. The machinery can have lacks of protections, malfunctions, obsolescence.

# The direct risks of use of the machinery




The machinery must be analyzed in its concrete operational condition: are noticed therefore the direct risks of accident, the characteristics of the commands, the behavior in emergency, the procedures of maintenance, the formation and the operational procedures.

# The safety of the machinery




The management of the safety of the machinery foresees the constant activation of procedures of verification, measure, maintenance and reparation. Every machinery can be inserted in the planning of such procedures and to memorize the historian of the controls and the in relief dysfunctions.

# The chemical risk of the plant



In presence of chemical risk, it is to point out well the chemical agents that are used on the machinery with the purpose to do its opportune evaluation.

## Component of the machineries




The machineries are able to them it turns to have some components that ask for procedures of verification and maintenance specific. To such purpose it is possible to create special cards which to connect a program of management.

#### Correlated files to the unities of the firm





# Registry of the Workers and working history




The registry file of the workers connects to every unity of the firm: it is possible to know where a worker operates, with what risks. It is possible to record all the variations of place of employment and the run of risk.

#### The worker's card




The card of the worker contains all the data that concern from the point of view of the safety and the health: the formation, the devices of protection used, the suffered accidents, the sanitary expirations, the calculation of the noise risk and the chemical risk.

#### The accidents




The card of accident allows an accurate recording of the conditions and the causes. The statistic of the accidents is a fundamental indicator to effect the prevention.

#### The instrumental measures




The instrumental measures effected in the business unities are recorded, are used for the evaluation of the risks and they allow to understand if there is relationship among the data of illness noticed by the physician and the presence of chemical risks, of noise, of climate.

### The calculation of the equivalent exposure




The instrumental measures are also used to make the calculation of the equivalent exposure to the chemical risk and from noise.

## The ergonomic analysis




Also ergonomic conditions are examined where in the places of employment there is necessity: the evaluation of the work, of the back-lumbar risk, of the stress and of the positions of job.

#### The card of the duties




The duties that intervene in phases of workmanship are examined by the point of view of the risk, of the forms of in demand formation, of the opportune sanitary protocol.

# The training




The training of the workers is recorded and planned. It is also possible to manage the e-learning of the worker and to appraise it

## The sources of external pollution




You it creates besides the connection among the external issues (liquid or in atmosphere) and the single phases of trial, with the purpose to be able to intervene on the causes that provoke her.

## To manage the prevention




Every situated of the firm can manage besides all the useful activities to the prevention from an index that it opens him all the useful functions.

## To shape the common Files





### To shape the duties





### To shape the wastes





## To shape the sanitary Protocol





## To shape the Procedures





# The Register of the environmental Data




Measures give instrumental the register of the environmental data is drawn, in a function that it allows the elaboration of it according to the necessities of evaluation.

# The Register of the bio-statistic Data





# The Register of the Events




The workers that are trained, they can enter to a particular format of the program, where they can send to the appointees (in the program and e-mail) the signaling of the found dysfunctions. These data are recorded and the appointees can record the solution that has been given to these problems.

# The Register of the Interventions




The planned procedures, when are performed, record in a historical file the actions that have been finished and the in relief measures. These data, over that to allow a historical verification of the problems, is used then for the environmental accounting.

## The food hygiene




For the alimentary firms or for the cafeterias of the other firms, the program furnishes a file of specific procedures for the single activities. The dangers, the limits, the measures and the correctives are proposed of which to keep in mind and to define the Points critical. Such aspects are managed then, as for the other procedures, with the planning and the recording of the finished actions. The management is possible of you acquire him and of the suppliers.

## The Register of the wastes





### The management of the issues





# The management of the unloadings





# The management of the yards




Also using some files furnished by the program is possible to shape the run times of a yard of job and to record the verifications and the finished corrective interventions of it. The gant of control is produced.

# The prevention in the jobs of extraction





# The planning and the motor of the expirations




A special file (the motor of the expirations) it records all the expirations that must be perform (authorizations, procedures of verification, control, measure and maintenance, formation, yards) and it plans those that are periodic.

# The management of the expirations




The management of the planning is facilitated with the possibility to create monthly cards (for the brief intervals) and the visualization of the daily, weekly and monthly planning.

## The card of the products





# Received products and sold





# The cycle of the product





### The environmental accounting





# The environmental budget





# The calculation of the equivalent carbon




In the environmental budget it is possible to transform the data (in coefficients base furnished by the program) in issues of equivalent Carbon, according to the formulation of Kyoto.

#### The elaborations of the data on I make a will





#### The Workers' share




The workers are the subject principal of the prevention and the improvement of the safety and the conditions of job. The program furnishes a form for the analysis of the risks from the group of workers that operate in the single phases of job. The formulation of the form favors a good knowledge of the problems.

### The distributed recording



A lot of recordings can directly be effected by the people that they operate for the different aspects: the signaling breakdowns and anomalies, the recording of the wastes, the recording of the products, the realization of the different procedures and the maintenances, the verifications of fire prevention, the autotraining. A specific form him active in Web with the password of the entrusted worker on the base of the qualifications that the worker possesses. The supervisor has the possibility to confirm the data without having to refer the recordings.

### The protection of the data



The access to the program happens on the base of keys of entry: the qualification to write in the program can be general or for single files. It is also possible to protect the single card from the writing. It is possible not to visualize any data besides (as those sanitary).


## The flexibility of the program





The use of the program is very flexible: you can use single parts or to proceed with gradualness to use all the functions of it. The system can work both for an only consumer, on a computer, or for more consumers online or in Intranet web, allowing a good collaboration among the different business functions, without duplication of data.

## The possibilities of use



The system can also work on a server web (managed by the firm group leader or from a society of services) and to be available for the compilation in the different establishments (also contemporarily with different languages) or in different firms. The key of entry allows to visualize only the data of the firm which the consumer is trained.
